



Terms and Conditions of Sale - Revised December 2005

1. VALUE ADDED TAX

Prices include VAT. This is at the current rate applicable at the date of sale.

2. DELIVERY CHARGES

All deliveries are free of charge

3. CUSTOMERS CONDITIONS

Endorsed on their order are binding only to the extent that they do not conflict with these conditions of sale, or any other of Cartridges4Causes Ltd conditions of sale

4. NON-STOCK ITEMS

Sent in accordance with customers written order and cannot be accepted for return by Cartridges4Causes Ltd. Orders for non-stock items must be confirmed in writing and cannot be cancelled.

5. CANCELLATION

Of an order to Cartridges4Causes Ltd MUST BE CONFIRMED IN WRITING BY FAX OR LETTER.

6. SHORTAGES , DISCREPANCIES

MUST BE NOTIFIED WITHIN 48 HOURS OF RECEIPT OF THE GOODS. Customers signing for the receipt of goods, not noting any shortages or discrepancies are liable for the loss. Customers signing for goods UNEXAMINED or DAMAGED must notify the details to Cartridges4Causes Ltd within 48 hours of receipt of the goods, to avoid liability for the loss.

7. PROOF OF DELIVERIES

Can be provided upon written request or by fax up to 45 days after invoice date only.

8. RETURNS

Goods cannot be returned unless they have a Cartridges4Causes Ltd Returns number. Any goods that are returned without this number clearly marked on the parcel will not be accepted. You are required to contact your sales representative to explain the reason for returns and a returns number will be issued. Any products that are ordered in error or are no longer required will incur a 15% handling charge. FAULTY PRODUCTS MUST BE RETURNED WITHIN 3 MONTHS FROM INVOICE DATE. After 3 months we do not accept goods back. Any goods that have been authorised for collection must be ready when advised as we will not re send couriers to collect returns.

9. CLAIMS

If any goods supplied by Cartridges4Causes Ltd prove on inspection to be defective in any way, Cartridges4Causes Ltd undertake at its option to replace the same or refund to customer the price of the goods. And in no circumstances will the liability exceed the cost of the replacements. Cartridges4Causes Ltd shall not under any circumstances whatsoever be liable for damages.

11. TERMS OF PAYMENTS

Credit terms require payment within 7 days from end of month. Cartridges4Causes Ltd has the right to withdraw credit facilities in the event of failure by the customer to adhere to the terms. It is an express condition of sale that in the event of payment not being made within the terms for payment the invoice will be automatically increased by 15%. In the event of legal action against the customer in order to obtain payment of any outstanding monies, all costs incurred are payable by the customer. Cartridges4Causes Ltd shall also be entitled to recover and resell any goods for which payment has not been received by Cartridges4Causes Ltd.

12. RETENTION OF TITLE

Ownership of any goods supplied will remain with Cartridges4Causes Ltd until such time as the customer makes payment in full. Although risk shall pass to the purchaser on delivery of the goods. In the event of payment not being made within 14 days of the due date, Cartridges4Causes Ltd shall be entitled to enter any premises where the goods may be to recover possession. In the event that the goods have been resold by the customer prior to payment, Cartridges4Causes Ltd will be entitled to the proceeds of any such sale up to the full amount owing to Cartridges4Causes Ltd. Goods not paid for shall be stored at no cost to Cartridges4Causes Ltd so that they are identifiable as belonging to Cartridges4Causes Ltd. Should the customer use the goods in a further production process, the property of the converted products will pass immediately to Cartridges4Causes and will remain with Cartridges4Causes Ltd from the moment of conversion until the customer has paid all sums due to Cartridges4Causes Ltd and the foregoing shall apply to the converted goods as to the original goods themselves.

13. GENERAL

No variations hereto or addition shall be binding upon Cartridges4Causes Ltd unless given in writing by a director of Cartridges4Causes Ltd. English Law shall govern these terms and conditions of sale.
